SaddleBrooke Tennis (STC) New Member Provisional Process

Ladies/Men

Process:

1. Obtain a New Member Provisional Form at the tennis center or print one from the STC website. Please complete the form, including your USTA number if applicable, and return the form to the STC Coordinator.
2. The STC Coordinator will now add an (N) or (A) following your name on the STC website indicating your New Member status and will enter your selected rating.
3. STC Coordinator will notify the Member/Orientation Committee chairperson and Provisional Oversight Committee (POC) chairperson of your New Member Provisional Form. The Member/Orientation Committee will inform an STC Pro to arrange your complimentary lesson.
4. If you have a Benchmark or computer USTA current rating, STC Coordinator will verify your eligibility for the rank you chose and remove the(N) from your name. No ranking evaluation is necessary.
5. After your complimentary lesson, you will be evaluated by the STC Principal Pro in either an OP or OPUS match. The POC chairperson will contact you to set a date for you to play. If you play on an OP day, a POC member will assign your court players. For an OPUS day, the computer will place you on a court with players in the level you have chosen.
6. Players being evaluated by an STC Pro will not have a (P) placed after their names.
7. STC Pro will notify STC Coordinator and the Provisional Oversight Committee chairperson of the results of your evaluation. The Pro and POC chairperson will sign your provisional form.
8. It is suggested you complete the OP or OPUS evaluation match **within 60 days** of becoming an STC member including the optional complimentary lesson.
9. If you disagree with the Pro's rating, you may begin the Provisional Process at the Pro assigned rating level. See "Rating Appeal Form" which includes the process.
