

## SADDLEBROOKE HOA#1 TENNIS COMMITTEE

### January 12, 2015 Meeting Minutes

The SaddleBrooke HOA #1 Tennis Committee meeting was convened at 4:00 pm on January 12, 2015 at the Tennis Center. Those in attendance were:

**Minutes:** The minutes of the November 10, 2014 meeting were approved.

#### **HOA#1 Update:**

- **Restrooms:** Linda reported that the project to upgrade/remodel the restrooms at the Tennis Center has been completed.
- **Patio sunscreens:** The sunscreens to be installed on the west side of the patio have been ordered by HOA#1. At this point, we do not have a firm installation date. Discussion followed regarding the lock on the screen's control box and who would have control of the key. Current plans are for the HOA#1 Patrol to assume this responsibility.
- **STC Club Championships:** This event will be held April 6 – 18<sup>th</sup>. The committee was asked by the tournament director to allow play to begin at 10:00 am in order to minimize the effects of weather later in the day. The committee reviewed the court assignment priorities in the STC's Rules (which have been approved by both HOA Boards): (1) Organized Play during prime time; (2) non-member residents (three courts); (3) League Play; (4) Official STC Events; and (5) Preferred Guest Program. Since organized play takes precedence over STC events, it was felt that this request would adversely impact the second session of OP that runs from 9-11 am. Following a motion and second, the request was not approved. Assuming there is no conflict with the third session of OP, the tournament can begin at 11:00 am.

#### **STC Update:**

- Ginger was introduced as the new liaison from the STC. She reported on a gender doubles league proposed by the STC to run for six weeks beginning late in January. Play will be from 2-4 pm on Wednesdays. Following a motion and second, the committee approved the exclusive use of courts #1-8 during this time frame.
- Ginger also mentioned that the STC intended to approve a six-week trial of the Organized Play Using Scoring (OPUS) System for ladies at its meeting tomorrow. Play will occur during the

second OP session on Friday. Members have the option of signing up for regular OP or OPUS. The board will evaluate the success of the trial in six weeks to see if it should be continued.

**HOA#2 Tennis Committee Update:** The HOA#2 Tennis Committee is scheduled to meet on January 22, 2015. Vacancies have been filled, and the members are: Riley Jackson, Chairman; Sue Ayres; Rick Waldorf; Dave York; and Bill Twitty.

**Adjournment:** The meeting was adjourned at 4:40 p.m. The next meeting will be held at 4:00 p.m. on March 9, 2015 at the Tennis Center.
